- An individual with Hong Kong permanent residency nominated by an individual or organisation;
- Working in Hong Kong-registered company principally engaging in any startup business or industry which is related to innovation, such as technology, emerging industry or invented new products, services and business model:
- Business focus and operations in Hong Kong and / or GBA and / or APAC region;
- A company founder/co-founder, owner/co-owner who undertakes an active management position, owns the intellectual property rights and/or legitimate rights over the company's product and/or service.



- Successful startup of a business from vision to reality;
- Recognised as an icon by industry & community;
- The business is operated by the founder;
- Companies registered in Hong Kong in or after 2020, which have been established for five years or less* with solid business operations.
